WHEREAS, the United Way of Hudson County ("United Way") provides rental assistance to 26 apartments in Hudson County that must be inspected at least annually; and

WHEREAS, JCHA staff have been trained to perform Housing Quality Standard ("HQS") inspections in accordance with the U. S. Department of Housing and Urban Development ("HUD") regulations and guidelines and utilizes the appropriate local and state housing, property and maintenance codes to ensure that the apartment is maintained in a sanitary and safe physical condition; and



WHEREAS, the United States Department of Housing and Urban Development (hereinafter referred to as "HUD") has designated the City of Jersey City to act as a recipient and administrator of funding under the Housing Opportunities For Persons With AIDS program (herein referred to as "HOPWA"), as authorized by the AIDS Housing Opportunity Act (42 U.S.C. 12901), as amended; and

WHEREAS, the purpose of these funds is to provide resources and incentives to devise long term comprehensive strategies for meeting the housing needs of low income persons with acquired immunodeficiency syndrome or related diseases (hereinafter referred to as "AIDS"); and

WHEREAS, HOPWA funds may be used to assist all forms of housing designed to prevent homelessness including emergency housing, shared housing arrangements, apartments, single room occupancy (SRO) dwellings, community residences, and supportive housing services, such as housing case management, in accordance with 24 CFR 574.300; and

WHEREAS, the Division of Community Development, (hereinafter referred to as the *DCD*), is the City's division responsible for administering all HUD entitlement grants; and

WHEREAS, the Municipal Council of Jersey City approved and authorized the submission of the 2020-2024 Consolidated Plan and Annual Application/Action Plan for Fiscal Year 2023 to the U.S. Department of Housing and Urban Development (HUD); and

**WHEREAS**, the Department of Housing and Urban Development has approved the City's 2020-2024 Consolidated Plan and Annual Action Plan for Fiscal Year 2023; and

WHEREAS, the JCHA will administer the donated leave program fairly and consistently without discrimination to any employees; and




